The Fit System Limited Guarantee covers replacement installations in your existing cabinet and is not valid for new cabinet installations related to new home construction or remodeling. Whirlpool makes no other guarantees as to the proper fit of your new Whirlpool Brand Low Profile Microwave Hood Combination (MHC) other than as set forth herein.

DISCLAIMER OF IMPLIED WARRANTIES; LIMITATION OF REMEDIES AND EXCLUSION OF INCIDENTAL AND CONSEQUENTIAL DAMAGES:

Your sole and exclusive remedy under this Limited Guarantee shall be the purchase price, as verified by a receipt showing the product purchased.

- ii) a legible copy of your sales receipt dated between 1/1/26-12/31/26 and proof of the delivery date, if utilizing the delivery date to calculate the 30/90-day claim periods;
- iii) a photograph of the existing model that is being replaced

Retain a copy of all documents for your records. Allow 8 weeks from the date your claim form is mailed for delivery of claim payment. **Complete the contact, model and purchase information below. NOTE: All fields must be completed to process your claim.**
